Check Washing – How Can You Protect Yourself From This Rip-off?

Do you put check payments in your mailbox for the postman or in a post office collection box? Check washing is on the rise. Criminals remove mail from these places looking for payments. They remove the payee and the amount by bleaching the check, and then, they write the check to themselves and increase the amount. They are also using the information on checks to take out loans or set up lines of credit.

There are six ways you can prevent this from happening:

- Pay bills online but not on a public Wi-Fi connection.
- Mail your payments at the post office.
- Use a non-erasable pen.
- If you are away, have the post office hold your mail or have a neighbor pick it up.
- Check your bank account several times per month.
- Contact your bank immediately if there is suspicious activity.

(Banks are required to replace funds stolen this way, but it must be reported within 30 days!) Source: AARP Bulletin March 2023 page 24-25



NYSUT Retiree Council 12 President's Message

Happy spring! I hope this finds that you are well! Those nice warm days we had were a tease before winter returned, but hopefully, spring will be here shortly.

Last week, I attended the NYSUT ED 51 meeting. We heard from NYSUT Vice President, Ron Gross, who is the officer who deals with retiree issues. He informed us that the NYSUT plan to have an "opt-in" for the retiree newsletters is going forward. Under this plan, you would receive one newsletter a year unless you opt-in. He stated that the program got pushed back a bit because there is now a new person in charge of the IT department, and that is where the mailing lists comes from. We still don't have specifics, but as soon as we do, they will be posted on the RC 12 website so you can sign up and not miss any informative, enjoyable issues. https://rc12.ny.aft.org Ron also spoke about the delay last fall of NYSUT calendars going out to retirees. He apologized and stated that he hopes the fall 2024 calendars will be sent out in a much timelier manner.

One of NYSUT's key legislative agenda items this term is to Fix Tier 6. The plan is to fix it slowly, over several years, the same way tiers 3 & 4 were eventually fixed. If you are asked to call, email, write or text a legislator to encourage them to support amending this tier, please consider doing so. I know being in Tier 3, I appreciated all the work NYSUT and our members did to fix tiers 3 & 4. If not for those successful efforts, I would have had 3% of my salary deducted every year while I worked, and in retirement, there would have been a Social Security offset. Whatever I received from Social Security would have been deducted from my pension. I am so thankful that the union was there for us; now we need to be there for the younger members.

Another great way that you can help support all of NYSUT's legislative efforts is by giving to VOTE/COPE. I have said this before: dues money is not used for legislative lobbying purposes. Legislative support comes from the members' voluntary contributions made to VOTE/COPE. Using payroll deduction makes it easy and simple. I have never heard of anyone having an issue with payroll deduction for any of NYSUT's programs, from VOTE/COPE to all of the NYSUT-endorsed member benefit programs. Many of these
