HEALTH INSURANCE INFORMATION FOR NYSHIP EMPIRE PLAN ENROL-LEES

If you are <u>not</u> enrolled in the **NYSHIP Empire Plan**, the following notice **does not** affect you.

"Once again, the NYS Department of Civil Service is conducting an eligibility audit of those enrollees with Empire Plan family coverage. Empire Plan participants who are enrolled through school districts and local governments should begin to receive letters at the end of February. It is very important that you follow the instructions and provide the requested information prior to May 4, 2016. If you do not respond, your unverified dependents will be deleted retroactive to January 1, 2016." From NYSUT STAFFER Sue Klug.

Editor's note: Retirees are always looking for ways to save money and cut costs. Here's one retiree's plan you might find useful. Bear in mind, not everyone will find the same results, based on what is available where you live.

My Cable Bundle is too Expensive!!!!

In January, we received our monthly cable bill for our economic bundle of phone, TV and Internet! Over the years, the exciting \$89.95 had ballooned into \$185 per month. I noticed they were even charging us an extra \$10 for broadcast TV and sports, and the fees and taxes now totaled nearly \$20. We were really aggravated and decided to look into other options.

Since we live in Fulton County, there is only one game in town as far as cable is concerned. Satellite starts out low, rates go up in 12 months, and monthly equipment charges really can add up. We are happy with our Internet service so we have decided to keep that for the \$60 charge unbundled.

We researched the TV tower locations on the www.antennapoint.com website and found we were about 35 miles from tower locations and that all the local digital broadcast channels seem to originate from about the same location.

First, we went to Amazon and found a number of options for digital antennas that pick up all local channels (NBC, ABC, CBS, PBS, ION, CW, MY TV, HSN). We purchased a small exterior antenna with a rotor built in for \$38. Another good option is a variety of indoor antennas by Mohu. You can go to Mohu website, put in your zip code, and it will tell you what channels each model could receive at your location

We hooked up the exterior antenna inside the attic and turned it to the direction of the best reception. We have 27 channels that all come in perfectly. For example, there are channels 6-1 (WRGB), 6-2 (This TV), and 6-3 (Comet). You need a TV with a digital tuner to receive these broadcast channels. If you have a newer TV (bought

since 2009), it has a digital tuner and will work with this antenna. Older TV's require an additional digital tuner box. The best thing for us is that there are 27 channels, which are absolutely free. How many channels you can get will depend on your location.

What about missing on demand? The websites of broadcast channels offer the opportunity to watch shows if you miss an episode. PBS has a huge amount of past shows such as Nature on its website.

If we miss some of the cable stations, the Sling TV base package includes ESPN, ESPN2, Disney Channel, ABC Family, Food Network, HGTV, Travel Channel, TNT, CNN, TBS, Cartoon Network and Adult Swim for \$20 per month. Netflix could be another option for \$9.

The home phone options include Magic Jack, Skype and Ooma. Magic Jack is very inexpensive, but you can't keep your home number, and you have to keep the computer running all the time so people can call you. Skype phone also needs to have the computer turned on, but it could be used to make long distance calls to people who use Skype. Ooma's router costs about \$100, and you must pay fees and taxes of \$3.46 per month. You can keep your phone number for \$40 and don't have to keep the computer turned on. It has voicemail, caller-ID, call waiting, and 911. My present phone costs \$41/month plus fees and taxes. After four months to make up for the startup costs, my phone bill will be down to just \$3.46.

We have decided to pay \$60 for Internet and \$3.46 for phone service after we pay for the equipment. In a future issue, I will let you all know how we do. If you have any questions about this article, email me at darkangelo@nycap.rr.com.
