#### Mike Corn Remembered

Mike Corn, this year's recipient of RC 12's Award of Excellence, passed away on March 26<sup>th</sup> after a valiant eight-year battle with cancer. His wife, Jan, proudly displayed our plaque at the funeral home during the calling hours. Mike served as a teacher member of the New York Teachers' Retirement System Board for 19 years and served on the NYSUT Board of Directors for 23 years. A chair was left vacant during the RA with two red roses and Mike Corn's name on it. Delegates honored Mike with a moment of silence.

## From the President's Desk... Jeanne Williams



Somewhere in New York State, a vibrant, talented young music teacher has just received a pink slip. Elsewhere, a 58-year-old mother of two with seventeen years in the NYSTRS has just been fired because her program has been eliminated. In a third district, both members of a married couple have had their positions cut to half time; neither one will receive benefits.

Ironically, I was typing this article when the telephone rang. It was my husband informing me that his position and program have been eliminated. According to Comptroller Thomas DiNapoli, 240 school districts in New York State are laying off roughly 16,000 teachers. How many more members of the educational community – teacher aides, health care workers, cafeteria workers, clerical workers, bus driv-

ers, and custodians – will be added to this total? What will this do to the economy of New York State?

Even more important is the impact the cuts have on the children. David Steiner, NYS Commissioner of Education, said that difficult budget choices are clearly taking their toll. "The social contract has broken down. We are fifth in the country on the disparity of what we spend from one child to another. No child deserves less than her brother, her neighbor, or the child in the district next door. How did it come to this?"

Unfortunately, the current political climate grants tax breaks to the wealthy at the expense of adequate funding for education and health care. Last year, General Electric, despite \$14 billion in worldwide profits (\$5 billion of this in US profits), paid no taxes. In comparison, if Gov. Scott Walker has his way, a custodian earning \$24,622 at the University of Wisconsin will have to pay 16% more of his pension and health care costs.

The strength of our organization is our membership. We cannot ignore these critical issues at such a critical time. Retirees are potent advocates, and what we do **does** matter. There are too many children and elderly who do not have a voice, and we need to speak for them.

Kathleen Donahue, NYSUT Vice President, called retirees NYSUT's "daytime warriors", who continue to fight to save Social Security, fight off attacks on pensions, and protect Medicare benefits.

As retirees, we know and remember where we've been and what we have accomplished. Now we have the responsibility to act, influence, and make a difference. We can make a difference by voting for our local school district budgets. We can influence our local boards of education by attending meetings in support of in-service teachers. We can act effectively if we attend the RC 12 luncheon meetings in order to remain informed and involved. This is not the time to give in, give up, or give out. Let us act together and act with courage! ..... Z------

### Something We Can All Celebrate!

You will be hearing a lot about the 20th anniversary of Retiree Councils in the coming months, and hopefully, not too many of you are asking what there is to celebrate. If you have been reading your council newsletter, attending your council general meetings, enjoying the social programs, attending the NYSUT Regional Conferences, and observing NYSUT's efforts to protect our schools and educators, there are clearly many things to appreciate. But here is one more, perhaps a little less obvious but no less important.

When the Councils were created in 1991, it took them several years to get organized, involve members, and create a program. But when they did, it became evident to all that the arena of greatest importance to us was the legislative arena. And the issue foremost on the minds of the retirees of that time was a COLA. Literally thousands of our fellow retirees' pensions fell below \$10,000 a year. This was because of the very low original salaries these members had retired on, but it was also due to the lack of enhancements their pensions received. To be sure, occa-

sional pension supplements had been given over the years, but these proved to be inadequate. We wanted a legally binding, yearly adjustment in our pensions that reflected the real increases in the cost of living that were so eroding our income and the dignity of our retirement. Then, at the end of the 90's, retirees came together in their demand that a COLA be enacted. Passage of this legislation was by no means assured. In fact, few, including many within our own ranks, thought we had any chance. But retirees were determined, and with NYSUT's support and leadership, we won! We did not get all we wanted. You never do. We did not obtain a full COLA, so our pensions continue to diminish in purchasing power. So much remains to be done. But we won, the legislation is on the books, a 'work in progress' for future generations to complete.

I looked over my recent NYSTRS pension statement the other day and noted that the sum total of my pension increases as the result of the COLA, per month, every month since the enactment of this legislation, now amounts to exactly \$350. Judy's, \$321. \$671 per month, over \$8,000 per year, that she and I would not have were it not for the efforts of NYSUT and your retiree council. Take a look at your NYSTRS Member Profile, first page, "Previous COLAs," and see the difference this legislation made for you.

### **Our Committee of 100 members** met with Senator Farley and Assemblymen Amedore, Butler, and Tedisco.

Assemblyman Butler: Butler is supportive of the millionaires' tax and understands our education issues. He reports that Silver says seniority is non-negotiable. He acknowledges that there are flaws in the funding formula but said they won't be corrected this year.

Assemblyman Amedore: He is passionate about protecting programs kids need. He is concerned that people won't buy homes if property taxes rise, schools are closed, and programs are dropped. He said we have to walk a fine line with the budget, but his priority is to invest in education. He, too, is also concerned about the inequities in school aid formula. He does not support raising taxes. He believes we need a whole new way to fund education. He thinks \$200K is too low for millionaires' tax. For the first time in four years, he felt that Sheldon Silver seems wishy-washy.

Assemblyman Tedisco: He, too, is concerned with funding formula. He also believes we need mandate relief.

Senator Farley: He used to mention being a NYSUT member; now he doesn't mention that. Instead he mentioned that NYSUT did not endorse him, noting that he got elected, in his words, "handily," without NYSUT. He said he will not be our champion on the lionaire's tax—he has "other" issues to deal with and claims no other group has pushed this issue with him. RC 12 Vice President Sandy Bliss spoke up and said she was there last week and discussed it with him. He insisted that "10 to 1 are in favor of whatever the governor wants." He raised his voice at us, would not answer questions, and answered AROUND questions. We left shaking our heads.


