# From the President's Desk... Jeanne W. Bennett




A number of national and statewide political issues and elections will either directly or indirectly affect each of us, yet statistics show that 50% of NYSUT members did not vote in the last election. Ideally, if 100% of NYSUT members voted, the direction of many local and state elections could be dramatically altered. As members of a democracy, we have a responsibility to be involved and informed.

Everyone should be registered to vote. If you have have moved you might need to re-register. Whether you moved because you were affected by the serious flooding from Irene and Lee last fall or choose to relocate you should make sure your registration is

current. For those NYSUT members who have never voted, register now! You must register to vote before the elections.

There are several important elections dates to keep in mind





- ♦ May 15 is the statewide voting day for school budget votes and for school board elections. This year, the constraints of the tax cap law will make passing our school budgets even more difficult. A school budget that exceeds the 2% cap will need a 60% approval rate by the voters. Due to last year's draconian cuts, many of the schools in our area are already encountering financial difficulties in providing programs and services necessary to sustain a quality public education.
- ◆ <u>June, August, or September</u> will be the primary election day for Assembly and Senate races and for congressional primaries. The Legislature needs to choose the date for the primaries after the redistricting battles have been decided. All 150 seats in the NYS Assembly and all 62 seats in the NYS Senate are up for election.
- November 6 marks the date of the general election this year which will determine who is president and will affect the balance of power of the U.S. Senate.

Members of RC 12 should also be aware of two dates set aside for lobbying on behalf of education. March 19 -20 and May 21-22, are two opportunities for the Committee of 100 to meet with local legislators. Consider joining other members of RC 12 engaging legislators in a discussion of education issue. If you are interested in participating, contact David King. As Andy Pallotta said, "Let's make 2012 the year we push the pendulum back in favor of public education."

Our efforts in support of education are especially important in light of some of the issues raised by Gov. Cuomo's second State of the State speech. For instance, Cuomo cited the local tax cap as a key accomplishment. However, New York's school districts currently have about \$1.86 billion less in state education aid this school year than in 2008-2009. The 2% cap could result in many more layoffs resulting in loss of programs and services. It also disproportionately affects lower-income communities.

Cuomo also proposed the creation of a new Tier VI pension plan for newly hired public workers, including teachers. Tier VI would raise the retirement age, increase employee contributions from 3 percent to 6 percent, and lengthen the vesting period from 10 years under Tier V to 12 years.

Teachers must always be wary of any efforts to change the NYS Constitution. If the NYS Constitution is changed to address the gaming issue as Cuomo has proposed, the door is opened to change our pension protections and raid our monies.

In his address Cuomo declared, "Consider me the lobbyist for the students. I will wage a campaign to put students first, and to remind us that the purpose of public education is to help children grow, not to grow the public education bureaucracy." As former teachers, we know we were never part of the "education bureaucracy." We were there first and foremost to help children grow. May teachers' efforts in this important political year continue to focus on the needs of our schools and our children.

#### RC 12 Resolutions for the Representative Assembly

Here is a summary of the Resolutions that originated in RC 12.

#### **Alternative Energy**

**RESOLVED**, that NYSUT pursue legislation for the use of any kind of renewable energy to help reduce energy costs and generate savings in schools and other public institutions; and be it further

RESOLVED, that NYSUT pursue legislation for the employment of local unionized workers and contractors, when possible, and the use of local supplies and materials in renewable energy projects; and be it further

RESOLVED, that NYSUT continue to work with environmental organizations and NYSUT's national affiliates to pursue such legislation.

#### Change Medicare ID Number

Whereas, Social Security numbers are used as the ID number on Medicare cards which are carried by Medicare beneficiaries; and

Whereas, this practice can contribute to identity theft; therefore be it

**RESOLVED,** that NYSUT work with its national affiliates to determine the process needed to discontinue the practice of Social Security numbers usage as Medicare ID

#### **Palliative Care**

Whereas, the United States is the only industrialized nation in the world that does not have a healthcare system, on the basis of equality, we must demand that quality healthcare be available to us all. Critically, chronically ill people just cannot wait; therefore, be it

**RESOLVED** that NYSUT support and urge its national affiliates to support efforts to include Palliative Care in an expansion of the Health Reform Act passed in 2010; and be it further

**RESOLVED** that NYSUT submit this resolution to the next conventions of the AFT and the NEA to consider incorporating Palliative Care as part of their national policies.
