# RC 12 Members were Active in Women's Marches

Many members travelled to participate in The Women's Marches on the day after the inauguration. They were accompanied by husbands, friends, daughters and even granddaughters. In our area, there were marches in Cobleskill, Cooperstown, Albany, Seneca Falls, Hudson, Poughkeepsie, and Utica. 400,000 people marched in NY City. There were not enough buses available to hold the people who wanted to attend so many drove to DC and stayed with friends.

A number of our members and friends sent us pictures and thoughts to share their experiences. Here are some of their words. Michele Kopp, a retired Niskayuna special education teacher, is still processing the enormity and beauty of the day and how it brings hope to all of us who believe in dignity, kindness and love. Clare Montero, a retiree from Van Antwerp Middle School in Niskayuna, travelled to DC with college friends and stayed with a friend in DC. She describes the event this way, "There were so many people there that the entire site was wall to wall people with nowhere to move. People were at their very best under the circumstances. Many of the signs that people carried were clever, downright entertaining, and beautifully crafted. We all felt unbelievable unity, sisterhood, and joy. How mind boggling to think that at that moment it was almost like holding hands, reaching out to women whose lives, languages, religions, were so different and here we were, so very much alike. I think the main message was that women will not abide the erosion of their rights and the rights of others."



Sarah Zogg, daughter of Northville retiree Barbara Spaeth, describes her ride to the march in the metro in the following way, "The car was jammed to capacity with women, and the energy inside was one of excitement: the kind of excitement you feel just before the roller coaster reaches the top of that first high peak, and we were all ready for our first thrilling descent onto the streets of D.C. At the march it was breathtaking and moving to see so many people gathered in, not only, peaceful protest, but in a protest where courtesy and kindness were as widespread as the crowd itself." She also declares, "We cannot be ignored, and we will be right there to hold the government accountable for every proposal that threatens our rights and futures. This was only the first drop of this rollercoaster, and we are prepared to be there for every twist, loop, hill, and valley they can throw at us."

### November Vote on the NYS Constitutional Convention

Holding a constitutional convention opens every part of the NYS constitution to be changed. Entire sections of the state constitution are dedicated to prescribing the powers and duties of state and local government. Real property and individual taxation are covered by the current constitution. Oh what havoc could be wrought depending on who the delegates are and what there agenda is. It's possible for seniors to have their STAR exemption on real property taxes taken away or slashed dramatically in the name of reform. The current tax exemptions for Social Security and State or federal pensions could be altered or eliminated. The \$20,000 exemption from taxes for 401k, IRA or other pensions, making it possible to stay in New York State and contribute to the economy could go away.

# Simplifying your life insurance options

As an educated consumer, you realize the earlier in life that you purchase life insurance, the cheaper the premiums will likely be. You're also aware that life insurance offers financial protection for your dependents upon your death, helping to cover the costs of funeral and burial expenses; assistance to help with your children's education; and offering financial assistance with paying debts and other expenses.

It can be overwhelming, though, trying to determine the best type of life insurance policy. Let's take a look at some of the different types of life insurance options available.

### **#1: Whole Life Insurance**

- This type of insurance is usually the most costly since policies are guaranteed to remain in force as long as premiums are paid. Whole life insurance offers permanent protection with premiums that never increase and builds cash

value you can borrow against while you are living (like a loan). *Important*: Understand that you will reduce your death benefit if you don't repay loans with interest and will no longer have coverage if you surrender the policy.

**#2: Term Life Insurance** – This type of insurance pays a benefit in the event of the death of the insured during a specified term, offering a fixed rate of payments during that time period. Once that period ends, coverage at the previous premium rate is not guaranteed and the insured would need to get

further coverage. Term life insurance (and its level term life cousin) is designed only to protect your dependents if you were to die prematurely -offering NO cash value.

**#3: Level Term Life Insurance** – Like term life insurance, level term life insurance pays a benefit in the event of the death of the insured during a specific time period. Premiums may not be

increased during the time period due to change in your age or health status.

#4: Universal Life
Insurance – This type of insurance offers a way to protect your dependents while building tax-deferred cash value. While the cost of a universal life plan needs to be covered so the policy remains in force, the policyholder has the option to adjust how much he or she will pay in premiums each year.
Policyholders can also access a portion of the balance without affecting the

guaranteed death benefit as the cash value accumulates over time.

Keep in mind that NYSUT members & their spouses/certified domestic partners can help protect their dependents from life's uncertainties with a variety of NYSUT Member Benefits-endorsed life insurance plans. Many of these plans offer group rates not available to the general public along with additional convenience and savings opportunities.
