What's Coming in 2017?

2017 does seem far away from 2014, but it is time to think ahead as New York State could have a constitutional convention in 2020 that might make changes to our teacher, state, and municipal employee retirement pensions. In New York State, every twenty years, there is a mandated vote on whether to call a Constitutional Convention --- also known as a People's Convention. It's important to understand that New York is the ONLY state to provide a constitutional guarantee that our pension, once earned, cannot be diminished or impaired. That constitutional guarantee could disappear, however, if a constitutional convention is held.

Currently, our pensions are not taxed by New York State. Collective bargaining, unemployment insurance, and the protections for the Adirondack Park are other examples of changes that could be made if there is a constitutional convention. In addition, there is talk of doing away with our traditional "defined-benefit" pension system and replacing it with a "defined-contribution" system, such as the 401k's that lost so much of their worth during the stock market downturn.

New York State would love to get its hands on the money from our pension systems. Public pensions are under attack, and anyone with an axe to grind would love to open up the constitution. Our opponents are using the argument that a Constitutional Convention will fix the dysfunction in Albany.

The New York State Constitution contains two avenues for its revision. One way is through a constitutional convention, which would allow wide modifications, and which voters must agree should be called. Therefore, in November of 2017, the question of whether to call a Constitutional Convention will first appear on the ballot. After a convention, voters must approve the proposed changes.

Another way to revise the Constitution is through individual amendments proposed by lawmakers, which must be passed by two separately elected legislatures (i.e. passed twice by legislatures elected in different years) and then approved by voters. There were a couple of constitutional amendments on the ballot this past November. If there is something that needs to be changed in the Constitution, this is the safer route to go. YOU ASKED FOR IT !!

At the September 30, 2014 RC 12 meeting, during discussion of a motion for RC 12 to donate to the Capital District Chapter of the NYS Alliance for Retired Americans (NYSARA), members asked, "What is the Alliance for Retired Americans, and what does it do?"

The decision was made to donate \$62.50 to the NYSUT Disaster Fund and \$62.50 to the Capital District Chapter of NYSARA.

The Alliance for Retired Americans (ARA) is an organization formed in 2001 by the AFL-CIO for the benefit of retirees of its affiliated unions and retired community members. "The mission of the Alliance for Retired Americans is to ensure social and economic justice and full civil rights for all citizens so that they may enjoy lives of dignity, personal and family fulfillment, and security." Every retired NYSUT member is a member of both the ARA and NYSARA since AFT and NYSUT pay the dues to ARA and NYSARA.

To accomplish the mission, ARA and NYSARA educate their members, advocate for their members, and activate their members to oppose any form of privatizing Social Security and Medicare, to fight any new tax breaks for the wealthy at the expense of programs that help seniors, and to oppose raising the retirement age. A weekly newsletter named 'Friday Alert' is emailed to anyone who signs up at the ARA website.

The NYSARA Capital District Chapter and Syracuse Chapter each meet monthly with speakers to discuss issues. Therefore, forums exist on the local, state, and national levels to provide a coalition of various unions and community groups to work together to achieve their mutual goals.

The Capital District Chapter of NYSARA will hold its biennial convention on November 12th at NYSUT headquarters. Officers will be elected, and attendees will hear experts report on senior issues. NYSUT Retiree Council 12 is a member of the Capital District Chapter of NYSARA. To protest the proposed change to a chained CPI, which would lower Social Security benefits, the Syracuse Chapter of

WE FIGHT FOR EDUCATION, WE SHALL NOT BE MOVED", summed up our beliefs. The fiery speech of The Rev. Dr. William Barber, president of the North Carolina NAACP, and the State of the Union speech of Randi Weingarten echoed this sentiment.



Getting involved in making sure this convention does not take place might include some ideas put forth by Peter Savage, NYSUT legislative representative, during the RC 12 general membership meeting on September 30, 2014. These ideas include "staying active with the political process" by informing our Senate and Assembly representatives that we are not in favor of having the constitutional convention in 2020 and by being one of the groups working together "to convince voters that holding a convention will not be in the best interests of the people of the state."

If voters agree that a constitutional convention should be called, then we have to show our strength by union solidarity, mobilization, and getting out the vote in record numbers. During the next couple of years, we need to talk and educate our families, friends, and former colleagues about the 2017 ballot with the admonishment "best leave left alone"!
