The following positions will be filled by an election at the NYSUT RC 12 general membership meeting on May 13, 2020, at 10:15 AM, at the Glen Sanders Mansion in Schenectady, N.Y.

Terms of Office: July 1, 2020 - June 30, 2022

President, 1st Vice President, 2nd Vice President for Legislation, Secretary, and Treasurer (Co-officers are permissible.)

For the 2021 and 2022 NYSUT Representative Assembly (RA) Convention - 2 delegates and 3 alternates - determined by the rank order of the number of votes cast. (The President is automatically the lead delegate.)

For the 2020 AFT Convention - 1 delegate and 1 alternate - determined by rank order of the number of votes cast. The candidate receiving the most votes will serve as delegate.

All candidates must be members in good standing per NYSUT RC 12 membership list.

To vote, you must be an RC 12 member and be present at the time of the election. You are not required to stay for the entire meeting nor purchase lunch in order to vote.

### A message from the President of RC 12 Stacey Caruso Sharpe

Happy Anniversary! This year, 2020, we celebrate the 100<sup>th</sup> anniversary of the passage of the 19<sup>th</sup> amendment which extended the right to vote to women!

Last week, I attended a NYSUT Capital District Regional Office (CDRO) meeting to discuss the presidential endorsement process and what, if anything, should be NYSUT's position. Jeanne Williams Bennett attended the one in Utica from the Syracuse Regional Office. Officially, NYSUT doesn't take a stand in presidential elections, but we are part of the conversation with our national affiliates, AFT and NEA.

In 2016, AFT did an early endorsement with the idea of having a voice in the endorsed candidate's platform. Many members felt that their voice was not included in the decision and that they were not being heard. For the 2020 election, AFT has changed their process to be much more inclusive. There have been many AFT-sponsored townhalls with candidates, question and answer sessions with candidates, telephone conferences, and many discussions at regional conferences.

At the CDRO meeting, there was a lot of discussion about the electability of every candidate, Republicans and Democrats. Then, there was discussion about which issues NYSUT looks at. Education, union rights, human rights, healthcare and Social Security are what the union stands for and works to improve for our members and those we serve. A discussion was held about where each candidate stands on these issues. The discussion led to many varying opinions. Ultimately, most agreed that a wait and see attitude would be appropriate at this time. In other parts of the state, people felt that an early endorsement for one of several different candidates would be appropriate.

At the AFT Northeast Regional Conference held in Saratoga this past weekend, there was also an in-depth discussion with AFT president, Randi Weingarten, about the new AFT endorsement process and about how we

choose a candidate to endorse, if we choose to do so. It was acknowledged that our many members belong to many different parties: Democrat, Republican, Independent, Working Families, Green, Libertarian and others. More people now choose to support local, state and national candidates based on the issues that the candidate supports and not strictly on the party that endorses them. The focus of the discussion at AFT was in a large part on how we make sure we hear all of our members' voices and how we educate members about the issues we stand for and where candidates stand on those issues.

Sometimes, people look at only one issue while considering candidates. Since there are many issues that affect our quality of life, I encourage you to make a list of the issues that are important to you and then to see where the candidates really stand on those issues. Don't just listen to 30 or 60 second sound bites, but look into the actions of the candidates. What bills have they sponsored, what bills have they actively worked to pass, what issues have they fought for, spent time on, and spent their own money on?

With the impeachment hearings currently going on, some people are burnt out listening to all the proceedings while others choose not to listen at all. The reality is that our future democratic process could be drastically changed. Our earned benefits the way we know them could change. I encourage you to stay informed. Listen to different news programs on different stations to hear different views. Listen to the same story from several different stations and see if any are alike or if they are all different. What makes the most sense given the evidence presented? It may take some time, but given what is at stake, isn't it worth your time?

All locals in the Utica Regional Office were invited to send a representative to share the views of their members regarding a candidate who would best represent our beliefs and values. # 2020 Census - Shape Your Future!

Beginning in mid March, nearly every household will receive a notice in the mail to complete the 2020 Census. The Census plans to work with the U.S. Postal Service to stagger the delivery so that they can spread out the number of users responding online and be able to better serve people if they need help over the phone. The Census plans to follow up in person with all households that don't respond. Special procedures are in place to count people who don't live in households such as students living in university housing or people experiencing homelessness.

#### WHY IS THE CENSUS IMPORTANT TO ME?

Data from the Census will determine how \$700 billion in federal funds will be distributed annually. Specifically, the data will be used to ensure public services and funding for public schools, hospitals, and fire departments. It will help veterans, children and families have access to quality health care, help seniors access food, housing, and medicines, and improve roads and transportation. It also helps determine how many seats New York State is allocated in the House of Representatives.

Remember, the Census is every ten years. For example, if every resident does not respond, and is therefore not counted, New York's public schools will receive less funding for ten years. This would include the allocation of Title I aid, the National School Lunch Program, Special Education grants, and even building aid.

#### HOW CAN I RESPOND?

For the first time ever, the US Census Bureau will accept responses online. If you prefer, you can still respond by phone or mail.

#### WHAT INFORMATION WILL BE REQUESTED?

The Census will collect basic information about the people living in your household. When completing the census, you should count everyone who is living in your household on April 1, 2020.

#### WHAT INFORMATION WILL NOT BE REQUESTED?

The Census Bureau will never ask for:

•Social Security numbers.

•Bank or credit card account numbers.

•Money or donations.

•Anything on behalf of a political party.

#### WILL MY INFORMATION BE KEPT CONFIDENTIAL?

Strict federal law protects your responses. The penalty for wrongful disclosure is a fine of up to \$250,000 or imprisonment for up to 5 years, or both. No law enforcement agency (not the DHS, ICE, FBI, or CIA) can access or use your personal information at any time. The data collected can only be used for statistical purposes such as how much federal funding our community receives.

# How Can You fight Inflammation?

Did you know that inflammation is linked to all the diseases related to aging? Doctors can tell you how to fight it in your daily life. When you are sick, there is usually inflammation, but chronic inflammation is caused by the immune system misfiring. Your body's own neutrophils and white blood cells cause damage to your organs.



This inflammation has 4 causes: long term infections such as HEP C, genetics, environment, and lifestyle. You can change your environment and lifestyle using a healthy diet and regular exercise.

Here are some simple changes that could make a big difference in your life. First, replace white bread with whole grain, and reduce the amount of sugar in your diet. This results in healthy bacteria inhabiting your gut. Next, eat dark fruits and vegetables (antioxidants), yogurt with probiotics, colorful salads, and healthy fats (olive oil, avocado, nuts).

If you follow the dietary advice above, you should reduce your belly fat which is known to increase inflammation. Also, learn to deal with stress. Exercise, yoga, prayer, and meditation are ways of reducing the effects of stress on your systems. Finally, getting enough sleep is the most important change you can make. Elizabeth Boham, director of the Ultrawellness Center in Lenox, MA, states, "When people give their body time to rest and lower stress, they have an easier time making smart food choices and getting exercise the next day." Think about making one small change at a time. It will be a great investment in your future.

Sick of TSA line? By Carolyn Darkangelo, Retiree Mayfield TA

If you have been thinking of Security Passes, here are some options:

TSA Pre costs **\$85** for 5 years. It gives you a faster security line (shoes on, laptop and liquids stay in your carryon). Apply at tsa.gov/precheck. You must go to an enrollment center for a background check and fingerprinting. (The downside- closest centers – Bradley Airport, Conn; Champlain, NY; or JFK airport.)

Global Entry costs **\$100 for five years**. It helps avoid custom lines and uses a secure kiosk. (It includes TSA Pre.) Go to cbd.gov/travel/ trusted-traveler-programs/Global Entry. (same as TSA Pre)

Another option is downloading Mobile Passport App which allows you to pre-enter trip info on your phone to go to priority customs line (cost --- **\$15 per year**).

The most expensive is Clear which involves fingerprint or iris scanning -\$179 per year. Whatever you do, you must plan ahead, because the screening process will take time (11 weeks at least). Happy Travels!

# Update for the TSA Article

My husband and I decided to apply for the Global Entry. CAUTION If you google Global Entry, the first items that show up in the search can be commercial ads which offer to charge you more (\$169) to do for you what you can fill out yourself. Make sure you are at <u>cbd.gov/travel/trusted-traveler-programs/Global Entry</u> They will charge you \$100!

The first application took 30 Minutes (watch the employment section) you need to click there even if you are not employed, because they then ask you your employment status – for us that was retird. The second one took only 20 minutes. Make sure you have the following information before you begin.

1. Passport 2. Drivers license 3. Employers for last 5 years 4. Addresses for last 5 years

6. A list of Countries you have travelled to in the last five years.

**Save progress** as you go my internet dropped out and I had to retyped one section. Finally, triple check your information. Your \$100 fee is nonrefundable. If you must correct anything later, you will probably need to pay another \$100.

We applied Jan 31, got our conditional approval Feb 2 and made an appointment At Champlain (at the border) for **Feb 4**. We drove 3 hrs. We arrived 40 minutes early, so we went in. The interview, fingerprints and picture for both of us took 5 minutes. By the time we got back home we got email that our global entries were approved. We supposed to get them in 10 days, but we don't need to carry them to fly only to cross into Canada and Mexico. The cards arrived on February 8.

### THEN

Late Wednesday February 5, the Department of Homeland Security announced it would block New York residents from applying for, or renewing membership in programs that expedite international travel.

The programs include <u>Global Entry</u>, which expedites entry into the U.S. from international destinations; NEXUS, which speeds entry to the U.S. from Canada; SENTRI, which covers entry to the U.S. from Canada and Mexico; and FAST, a program for truck drivers crossing into Canada or Mexico.
