Jim Marquit was the founding father of RC 12 and our first president. Sadly, we received notification that he had recently passed away in South Carolina where he and his wife, Annemarie, had moved to be closer to family. Originally, I met Jim at the NYSUT Committee of 100 in Albany when we were both in service educators. For many years thereafter, I saw Jim regularly, usually at Senator James Seward's office. When I retired from teaching and joined RC 12, Jim was a welcome and familiar face.

Like many union leaders, Jim was a man of many talents. For more than 45 years, he was a member of the Middleburgh Rotary Club. He was very proud of his military service and often advocated on behalf of our veterans. Jim retired from teaching English and public speaking at Middleburgh Central School.

friends of Jim's. Marlene shared some of her memories: "Jim was the director for the high school plays for many years—a job he greatly enjoyed. He also was proud of his years as high school track coach. On a lighter note, Jim was never late for a meeting. In fact, he had the reputation for being the first in attendance—and the first to leave."

I would be amiss if I did not comment on Jim's affiliation with the Middleburgh United Methodist Church. Jim was a long-time active member of the church, serving as a trustee and singing in the choir. He also served as our substitute pastor when needed. He was an excellent speaker, and I suspect that he filled that role frequently in every Methodist Church in Schoharie County and probably beyond, as I know he was called frequently. The (Methodist) Conference awarded him with a citation a few years ago for "answering the call when and where needed."

Jim touched and enriched many our lives, and his influence will be felt far into the future.

What Do You Need to Know About Thrombosis?

Thromboses are blood clots in the veins. The two main types are Deep Vein Thrombosis (DVT) which is usually in the legs and Pulmonary Embolism (PE) where a clot breaks loose and lodges in the lung. This type is often fatal. Risk factors include obesity, lack of physical activity, family history, genetic factors, and prior episodes of clotting. PE and DVT kill up to 100,000 people a year in the US.

To reduce the risk of having a thrombosis, you should exercise regularly and work to lower your Body Mass Index to 25 or below. Symptoms of thrombosis include swelling, pain or tenderness in the legs, red streaks or other discoloration, and skin that feels warm to the touch. PE symptoms are shortness of breath, rapid breathing, chest pain, rapid heart beat, or lightheadedness.

If you are traveling four or more hours by plane, train, or bus, you should take precautions to prevent DVT. Move around as often as possible by walking in the aisles when allowed. **Avoid** crossing your legs. **Avoid** wearing tight clothes that can restrict **blood** flow. Stay hydrated, and **avoid** alcohol before and during **travel**, and stretch your legs and feet while sitting. If you are traveling long distance by car, plan stops every couple of hours to stretch and walk. For more information, go to www.**heart**.org.

Jim Marquit, an RC 12 Leader

Jim and I retired during the end of the last century, a period of some calm in the affairs of teachers and of NYSUT, and at a time that led to doors being opened to retirees as organized members of that body. 1991 was the date. Incorporation was the aim and the problem, and that was where Jim entered the equation. Someone, probably the NYSUT Regional Director, recommended that Jim be selected to assume the responsibility of getting the organizational ball rolling for the retirees, and he did! The names of all retirees from the region were identified, a meeting date was established to which all of these retirees were invited, meeting arrangements and protocols for creating our organization were established, the meeting was held in Cobleskill, and we were off!

It is worth noting that there were exactly seven (7) people in attendance. (7!) These 7 represented the genesis of RC 12's creation. Jim was our leader during this developmental first year and was elected as our first president the following year, a year that led to the continuous growth of Retiree Council 12 that resulted in its becoming one of the predominant retiree councils within the state.

Jim had a long life. It is hardly unusual for people so far removed from the scene of early promise and early success to fade from the memory of those who follow, but every one of you reading my words owes a debt to Jim Marquit for the benefits we have all acquired through our membership in RC 12. When it was created, Jim was there.
