- B. Budget In the new budget presented, nothing was changed. Attempting to predict income is a challenge. Expenditures will be limited due to COVID. Pallative Care Hospice Act was passed in the Senate. Stalled in House of Representative Bill # 852080

- VI. Directors reports Vickie, Sue, Marge, Theresa
- A. Vickie is not in touch with too many members. There continues to be no major decisions regarding whether city schools need to be opened. It's difficult to make a decision. Many students are lost in loop of remote learning because they don't all have internet access. New teachers will not be recognized via on line learning. All of this is a challenge, especially for kindergarten students. It's questionable whether there will be enough teachers and/or paraprofessionals to cover the classes. Not sure of retirees. There may be possible proposals of Spectrum providing internet for all.
- B. Sue reported that paraprofessionals were paid until end of June and there were no layoffs. Unemployment was provided for summer employment. Schenectady looking at half day programs: In the middle school 6/7 students. in high school 7/8 grade students. Masks questioned. Some paras are staying home and getting paid while some rotated in. 47% of the population want to keep the kids home. Bagged lunch morning breakfast will be provided.
- C. Margaret reported there was a variety of education forms from school to school. Nothing is unified. BOCES is questioned from District to District. There are many online teaching inconsistencies. There is a backlash of some employees get paid who do nothing. How to assess teachers with students is a unpredictable. List of retirees need to be sent to Kathy/Stacey.
- D. Theresa reported that letters were sent to teachers in Gloversville. Three models were presented. 27% of the population want to stay home. There's every other day proposal which could be confusing because all BOCES programs are different. She also felt that insurance is an issue with retirees, and it

seems to be going backwards because cheaper insurance is being approved. Without using contract language confusion arises during switch overs.

- VII. NYSUT Retiree Services Consultant Report Jennifer Shaad-Derby
- A. Many retiree teachers and bus drivers are being called in to return to school but many do not feel comfortable going back. Parents are making decisions to home school because they don't believe in mask.
