## 2021.03.16 NYSUT RC12 GENERAL MEMBERSHIP MEETING HELD ON ZOOM

- I. President's Report
- A. NYSUT Code of Conduct read.
- B. RC12 Elections will be held at the May 12 meeting. Anyone who is interested in being elected to a Director position is asked to contact Kathlene Lyman at <a href="mailto:namyl4@aol.com">namyl4@aol.com</a> for an application.
- C. Budget Walsh and Tedesco report that funding is looking good due to Federal Relief bills. However, the following year, the state revenue may fall short. Grants for aides and PreK were lumped together. Four members of RC12 attended for Committee of 100.
- D. School board budget votes will be held on. April 1. The State budget is needed for districts to make plans. Peter Kim and Joe Morabie are available if anyone one knows anyone interested in running for their school board.

NYSUT heard there that money is being made available to help people run for positions who are not pro education.

E. NYS Education is asking for a waiver from testing requirement for 2021. Chancellor Rosa is on board to get the waiver. However, at this late date, there has not been a response from the government. NYSUT will be supplying information so parents can opt their children out from the testing for grades 3-8. At this point only four regents exams will be conducted: ELA, Living Environment, Algebra, and Earth Science exams

Advocates are bringing issues forward revealing the reality of what students are dealing with regarding the virus such as experiencing deaths, continually testing positive, mandatory quarantines, and changing that happens from day to day are discussed. However, there continues to be advocates of accountability.

- F. Safety and opening all schools. There is a transition regarding social distancing from six to three feet. Teachers are getting vaccines. Some districts asking for more social workers. Many kids not logging on and plans have been put into place to check into reaching out to those students. Time to receive the Covid vaccine is being provided and there has been a two year extension for the Covid death benefits.
- G. Retirement Advisory Committee (RAC) Communications Committee will be meeting on Thursday. An AFT Action Training was held in the fall to help get data bases set up.
- H. NYSUT Assembly will be held online again this year. The Retiree Councils are requesting more involvement.
- I. Retirement workshops are being held March 25 and May 6.

- J. Vaccine information can be found on the RC12 website. Some retirees are receiving calls and emails from their counties and insurances companies. When a vaccination date is set, individuals may want to call places where they requested to be placed on waiting lists.
- K. Nursing Home Reform has been passed by legislators regarding safe staffing ratios. However, the governor has not signed the bill. Website links may be placed on RC12 website for more information.
- L. Covid Relief Bill entails many areas for benefit: child tax credits, lower health insurance premiums, reopening classrooms, benefits for unemployment. AFT is looking more into the bill to provide information. Legislators are available to speak more on the details.
